- 2. Approval of draft October 20, 2016 Minutes approved
- 3. AOA/FIS Joey Lavigne
 - a. AOA is creating two new committees; the Athletic Committee, the Coaches Committee and the High Performance Committee
 - b. Joey was tentatively assigned as NCD representative for first meeting of the Athletic Committee
 - Athletic Committee had first meeting to review terms of reference; committee has one rep from each division (Nick Kwasniak SOD, Dave Bradley LSD, Dave Hunt NOD, Joey NCD) chaired by Athletic Director (Mark Marshall)
 - d. Joey suggested that we also discuss with Pat Biggs and Bruce Monkman regarding their participation, and make recommendations to the board for rep for each committee

Brent moves that NCD accept the most recent MOU version, Jay seconds, board approves

- 5. Officials Ben Kislich-Lemyre
 - a. Back protectors are not required this season; highly recommended but not mandatory
 - b. Officials list is being updated; especially for level 2 and 3
 - c. Still need to have our local officials register as officials/volunteers on the AOA site although it remains a grey area
- 6. Schedule
 - a. Version 10 is the final version except:

- 7. NCO Incorporation Ben
 - a. NCO is incorporated in Ontario
 - b. Next step is bylaws, which will be primarily boilerplate, NCD will need to approve
 - c. Third step is operating procedures
 - d. Class A membership NCD, Class B membership OSZ, Class C membership Parents (one NCO parent per athlete)
 - e. Directors Class A 3, Class B 3, Class C 1
 - f. NCO likely needs to become an NCD club
- 8. Finances/Budget Jay Swayze
 - a. Will likely have \$3000 surplus plus the GIC money (\$10K)
 - b. Ben suggested that we should keep some money in reserve in case any liabilities pop up from the NCO incorporation
 - c. Suggestions include Bnet, athlete development camp with NCO,
 - d. Discussion converged on buying 20 rolls, half for CF and half for CALAB Ben moves that NCD buy 20 rolls of Bnet (to max of \$10K) to be split between CF and CALAB equally; Brent seconds; Board approves ACTION Jamie follow up on the purchase
