#### **Attachment 1**

#### **Requests for Financial Support**

The National Capital Division of Alpine Ontario is a regional sports organization that coordinates, organizes, promotes, and supports all levels of amateur ski racing on behalf of all NCD clubs. Our mandate is to: encourage broad based participation, encourage personal growth and develop individual potential, and encourage athlete's progression from Club to Division to Provincial teams while providing the highest quality programs at the lowest possible cost to athletes.

In line with this, NCD has created a policy for considering one off requests from athletes or coaches to further their progress and skills.

#### **Guiding Principles**

- Requests will be considered on a case by case basis;
- NCD will seek to ensure athlete, coach, gender, sport and ability equity;
- Funding is subject to the health of NCD finances; and
- Will target an average of \$5,000 per year, +/- 10%.

#### Criteria

#### Athletes:

- NCD will consider a maximum of 50%, or \$1,500 per athlete. An athlete may only receive the funding 1x.
- The funding must be for a high performance opportunity:
  - A high performance camp outside of the NCD that does not compete with NCD camps
  - A high level competition: Regional, Provincial, National or International
- The athlete must be a registered, active member of an NCD club
- The athlete must be endorsed by their Head coach and club as living up to the code of ethics

#### Coaches:

- NCD will consider a maximum of 50%, or \$1,500 per coach. A coach may only receive the funding 1x.
- The funding must be for a high performance opportunity:
  - A high performance camp outside of the NCD that does not compete with NCD camps



- o A high level competition: Regional, Provincial, National or International
- Progression in their coaching qualification
- The Coach must be a minimum level 2, with two years at the club?
- The Coach must be endorsed by their Board as living up to the code of ethics

#### **Process**

The Club will submit a request for funding, with the amount, the person(s) who will participate, the event/activity to the Chair, NCD, and what % of the funding is to be provided by the coach/athlete/club.

The Chair NCD will review the criteria and make a recommendation to the NCD board for approval.

#### Attachment 2

#### NCD Communications Considerations for the 2019-20 Ski Season

**Background:** Currently the NCD maintains one 'owned' communications channel to support its efforts on behalf of members. On NCD.ca there is a warehouse of static information such as club and program information, safety protocols, etc. As well, there is evergreened information such as race schedules, race results, points and board meeting minutes. During the season, information is added on a near-weekly basis. We do not promote the existence of our website to our members.

Additionally, the NCD has begun to successfully leverage AOA communication channels to highlight and promote ski racing and associated activities in the NCD. We provided bi-weekly content to AOA last season, the majority of which was published in either the AOA newsletters or on their social media assets.

Last season, the NCD's Board raised the issue of potential fundraising down the road. Without communicating the NCD's role and mandate, it would be difficult to effectively launch fundraising amongst its membership base, or the broader community.

**Audience:** Primary audiences include dues paying members (parents); current NCD ski racers, volunteers and coaches. Secondary audiences include alumni NCD ski racers, volunteers and coaches; the broader ski racing community; the sporting community within the Ottawa region.

**Considerations:** The NCD board may wish to discuss the benefits of a more high-profile communications strategy with any or all of the audiences identified above. In particular, those who pay NCD fees may wish to learn more about how their dues are used. At the same time, it can be expected that attachment to the NCD is less than to the individual racing clubs to which our members belong, so it may not be useful to launch multiple comms channels without a strategic multi-year plan.

#### **Potential Tactics for Discussion:**

- Audit and update NCD.ca from perspective of user experience, quality of information, etc
- Annual email to dues paying members at beginning of season to:
  - Explain role of NCD/how their dues are used
  - Let them know what information is available on NCD.ca
  - Encourage them to subscribe to AOA Comms channels
- Social channels for NCD?
- Other tactics to consider?
